I have yours of December 13 and am very glad to give you the information you ask.

The elevators, as well as the shafts, are included in the estimate, as is a complete air conditioning system. The screens and storm windows are also included.

You have the right to approve the selection of all sub-contractors - as is usually the case in a contract of this kind.

I agree that we should have an approximate estimate for the garage and have advised Mr. Lee accordingly, as it is difficult for me to guess the cost of a building of this type. The garage is bigger than I realized - it covers a floor area equal to about 50% of that covered by the main house. On the second floor there are nine rooms and three baths, which is equivalent to the contents of a fair-sized dwelling.

I think you will find the Howell Company satisfactory and I know they will make every effort to please you.

Dear Mr. Schmidt:

I have been increasingly puzzled (an understatement) by the continuous delay in receiving from you any sketches whatever of interior detail I asked you to submit for the principal first and second floor rooms of my new house. Some four months or more ago I requested such sketches, with particular emphasis upon types of cornices, in order to discuss them with you and either approve or suggest changes I might wish to make in line with my general ideas for the interiors. You agreed to draw them without delay, and also concurred in my idea that I would decide with you the architectural details of interiors and that Mrs. Douglass and I would go on from there. Subsequently I asked you several times about the sketches. Nearly two months ago, in a letter you wrote me enclosing other material, you mentioned that I would receive these within a few days - but I did not. On Friday, December 6th, when several of us met at Hillcrest and the question again arose, I was completely taken aback at being shown the builder's detailed work-plan for the mouldings for the morning room where we were standing, which I thought much too heavy and not suitable for that small room. When two wooden specimens of mouldings were also shown me, I stated that I preferred to see sketches before deciding, in order to be sure not to have Georgian or other types I might not wish to have in rooms which I may, and do, plan to have in a different or even French decor.

Now comes your letter of December 16th, saying "In the Living Room at Hillcrest it is planned" (not by me, I may inject) "to use a cornice similar to that in the Dining Room at 740" ... and so on. I very definitely do not want such a heavy cornice, as I consider it unsuitable for my country living room which, a), I wish to be less formal and, b) is not as high as the dining room here.

Moreover, upon inquiry I learn that not only have most of the mouldings been ordered and many received but that the one in my sitting room is already partly installed. I have therefore directed Mr. Sleinkofer to have all work on this stopped until I know from you what the sitting room moulding looks like, and to hold up all other such installations until I make the decision as to whether I want any or none of them used.

This letter is to advise you that if what I have requested is not received shortly, my intention is to ask Mrs. Douglass to make such plans and drawings in consultation with me.

Notwithstanding the incident when the outside trim was painted white without my being consulted and when upon my surprise at seeing it I had it repainted in grey, I have until now been reluctant to let myself wonder if you had hoped that by going shead with certain features I might acquiesce rather than veto them and have them done over. I would be sorry to believe that now, but I can think of no other reason for your proceeding with cornices when I had repeatedly indicated that I wished to approve of the designs in advance.

I may add that it is not my intention, in the present circumstances, to pay for any of the mouldings already ordered and made if I decide not to use them.

This situation is the more disturbing to me since I have purposely remained accessible for the past year and more in order to be available for decisions which I myself wished to make.
