Dear Mr. Schmidti

As I wrote Mrs. Schmidt when she asked for similar cooperation several years ago, personal loans have brought only unhappiness and loss of friendship to our office, with the result that for years past we have discontinued making them almost without exception. While my present feeling is that I cannot wisely depart from a policy the wisdom of which time has only made clearer, I will not say "no" to your request without at least a little further information with regard to the circumstances which call it forth.

It would appear that you have been working for some time on plans for the "Middlebury property"; that these plans are well along; that when they are completed, you are to receive \$2,500 plus any actual bravel expense; that their completion will be effected within the next few weeks; and that the financial accommodation you are now asking is to enable you to meet the current expense of making these plans until the \$2,500 is received. Are all of these inferences substantially correct? If so, how soon is it probable that the plans will be completed and delivered? To what extent have you obligations to draftsmen and others which must be met when the \$2,500 payment is received and how sure are you that you will be able to pay at that time such an advance as you are now requesting?

with this information in hand, I will be glad to give you a prompt reply.

In considering this matter I would feel the more ready to look with favor upon it had I been happier in your relationship to the Philipse Castle Restoration. It was because I felt that you lacked interest in the undertaking and were not giving it the time and attention which I thought it required that I suggested and brought about your withdrawal from the enterprise. I am aware of the fact that your feeling, on the other hand, was that you were giving far more time and attention to the Restoration than you were being paid for. I realize that the enterprise was a small one. Nevertheless, because of its public character and because through me and the various members of my family you and Mrs. Schmidt had been put in the way of professional business which I had always assumed paid you well and was of value to you, I had hoped - since work in your own profession was not plentiful and you had time on your hands - you would have felt the Restoration was not unworthy of your best effort. But this is all past. You have at least been made good, through the payment I later made to Mrs. Schmidt, for the full amount of your out-of-pocket expense for the Restoration and it is a closed issue.

Elena and I have always been most grateful for opportunities to be of professional assistance, and had hoped that we succeeded in showing our appreciation in the most important way - that is by giving our best attention to all matters, large or small.

As my conscience is clear, I should like to feel that you will perhaps come to think of me in a little better light as regards my services to the Restoration.
